- **USFS Filing** – There was discussion about whether FSCOH should submit an application for USFS Membership. Applying and being accepted will not impact the club's current ISI membership. As a USFS member, skaters will be able to participate in more advanced skating events and will enable FSCOH to host test sessions, etc. This will require a Test Chairman Position in the club be filled at some point in the future. Anyone interested should speak to Chris Hannemann or Stan Houston. Linda moved the club proceed with USFS application. Cindy and Greg seconded the motion. The membership voted to submit the application. Stan anticipates formal acceptance of FSCOH to the USFS will take one year.
- **Board of Directors - Treasurer Vacancy** - The Treasurer's position is open. - **Rink Monitors-** We need volunteers to be Music/Ice Monitors to support Chris. He has been filling every session. Jim volunteered for Sunday. We will need a monitor for Wednesday as well. *Please contact Chris if you wish to volunteer for Wednesdays or alternating Sundays with Jim.*
- **Summer/Fall Club Ice** – Saturday club time has been suspended for the summer. Provided there is enough interest, we can resume the session in the fall. The members discussed reserving Sunday 4:00 – 5:15 and Wed 5:00 – 6:15. Payments for club ice time have **not** fully covered the fee charged by Aspen Ice. Steve (rink manager) agreed move Wed. hockey and accept however much we can afford to pay in a good faith agreement the club will remain active on Wed. Therefore, we need to book Wed for 22 weeks. Cindy moved to extend Wed. club ice reservations to 22 weeks in the spirit of cooperation with rink management. The motion was made and passed.
- **Club Ice Enrollment and Payment** - Current ice fees charged by Aspen Ice are \$360.00 per hour and \$450. per one and a quarter hours. **To continue our ice time without interruption**, we need to collect payments ASAP. We need to make a \$2,000.00 down payment for club sessions this Wed. *If you plan on continuing to skate Wed and/or Sundays please bring a check to the next club time and sign up there.
